NOTES

These fees apply from 8 July 2024.

These fee estimates assume that the family is entitled to sufficient CCS hours to cover their 'booked hours' per fortnight. Imagination Garden operates for 11 hours per day, so the 'booked hours' are the number of days per fortnight x 11.

These estimates show the fees payable, <u>after</u> the 'CCS withholding' (5% of CCS for most families) has been deducted by Centrelink.

The 'CCS withholding' is paid back to families after Centrelink completes the annual 'balancing' process.

These estimates <u>do not</u> include the \$2,050 discount for children enrolled in the kindergarten program. The 'free kindergarten' subsidy is credited to family accounts weekly and reduces your fees further.
